#### What is a Grievance Committee?

Every league should have a Grievance Committee composed of the captains (or sponsors) of each team in the league. Grievances must be submitted to the league secretary in writing within 48 hours after the dispute has occurred, except protests involving the use of unqualified players, which must be submitted within a reasonable time.

The vice president shall then request the league secretary to call a meeting of the captains (or sponsors) of each team in the league involved, giving at least 24 hours notice of such meeting. The vice president shall chair the meeting and the league secretary shall keep a written record of the results of the issue.

Such meeting must have a majority attendance and only captains not involved in the dispute shall have a vote (decision by majority vote). All votes shall be by secret ballot. In case of a tie, a second ballot will be taken and the chair-person at that time shall also cast a ballot.

The results of this meeting shall be the final decision.

#### A Question for Readers

A player signed with one team in the league. What does he have to do before he can play on another team? This dispute happened on our league. Ask your readers; I'll send our answer later.

The way we see it, from our "neutral corner," some of the problems mentioned are easily resolved. For instance, a person wrote, "There cannot be any byes in the first round." Obviously, this is not so. If there are six players, there are two byes. However, in this case a 4-bracket chart can be used with two sub-brackets. Ergo, the players who are not in the sub-brackets play one round less, assuming they go to the finish, thereby in actual fact they received a bye.


Without more detail, I cannot picture in my mind what Robert Brunskill said on page 2 of the *Board Talk*.


