## West Coast Canada, U.S. Shufflers Launch Goodwill Mission

"Everybody was a winner" in first match, says organizer Gordie Smith

Gordie Smith of British Columbia, Canada, and his partner, Russ Miller of Washington, U.S.A., have launched a "hands across the border" shuffleboard effort which was so successful in its introduction that it may become a tradition.

On March 5, 36 Canadians (34 from the ANAF 68 in Vancouver) boarded a bus bound for Washington, their neighor in the U.S.A. They had asked 36 U.S. players to participate in matches of nine games with total points deciding the winners. The names of the 72 players were put in a hat. Names were drawn putting one U.S. and one Canadian as partners, then drew for teams, 12 in all, with six on each team. The bus dropped 12 players off at three locations: Old Edison Inn in Edison, 12 at the Corner Tavern in Bow, and 12 at the Sportsman Tavern in Stanwood.

So, who were the winners? Nobody seems to know -- or care for that matter!

"Almost all of the matches went to the last game and most games were real close," Gordie reports. "The response from all the players was super! Everybody had a great day. Everybody was a winner because this day gave us a chance to meet new friends -- and did we ever!

"We have been playing matches against our U.S. friends for a few years now, but it only involved the top players from Canada and Northwest Washington. This day was real special as it involved all calibre of players, playing together and having a good time doing it," he said.

Gordie and Russ are working now to arrange a return match at the ANAF 68 in Vancouver in the near future and already have a list of people who want to participate.

(Editor's Note: We salute Gordie and Russ for initiating this goodwill mission and are proud that the three locations in the USA -- Old Edison Inn, Corner Tavern, and Sportsman Tavern -- and the ANAF 68 in Canada, are all members of our national shuffleboard network.)



## Pacific Northwest Players/Sponsors Organize

The Evergreen Shuffleboard Association became a reality shortly before 10 a.m. on Saturday, Feb. 25, during a meeting prior to the 14th Annual Master's Doubles Tournament at the Fir Cone Tavern in Shelton, Washington. The association will be for players and sponsors in Oregon, Washington, and British Columbia. The initial goal of the association is to help with scheduling of tournaments to prevent having multiple tournaments on the same weekend.

The initial dues to the association are \$15 per year (for players and sponsors) with at least half of the money collected being returned to players on a point system to be maintained through the end of 1995. Dues need to be paid no later than the Grand Masters Tournament at the Whistling Oyster in Quilcene, Washington, Aug. 2-7.

Players and sponsors are urged to pay their association dues as soon as possible. Part of the money collected will help pay the cost of mailing the Evergreen Shuffleboard Association newsletter. The association can only afford to mail the newsletter to non-members for a couple of months before starting to deplete the money which will be returned to players. Dues can be mailed to The Whistling Oyster Tavern, P.O. Box 580, Quilcene, WA 98376. Checks should be made out to the Evergreen Shuffleboard Association. Sandy VanWagenen of the Whistling Oyster volunteered to be the treasurer for the organization and has opened a bank account on the association's behalf.

Although the association did not elect officers, those in attendance did agree on a number of area representatives: Chuck Norris, Oregon; Russ Miller, Northwest Washington; Rick Gindt, Tacoma area; Doug DeBois, Southwest Washington; Gordie Smith, Canada. We are still seeking a representative from Eastern Washington. (Volunteers from that area should send a note to Jim Manders, P.O.

There are probably a lot of questions about the association, but one misconception needs to be cleared up. You don't have to belong to the association to play in tournaments, but those who don't belong won't receive points (and possibly money) from tournaments. Sponsors do have to pay the \$15 association fee to have their tournaments sanctioned and for players to receive points from them.

Here's how the points will be awarded.... This is an arbitrary system arrived at by the secretary and if (players and sponsors) think there's a better way to do it, we'll talk about it for the 1996 season. Points will be awarded to all players who participate in a tournament. The winning team will receive a number of points which correspond with the number of teams entered.

Example: Doug Buhl and Jim Allis won the Fir Cone Masters Tournament. There were 24 teams entered so they each receive 24 points. The second place team will receive 23 points, third 22, fourth 21, fifth and sixth 20 each. If the tournament has more than 20 teams, two points will be awarded to each participant. The association will "pay" points to the top six places in all tournaments (5th and 6th will always be considered a tie).

One of the services that will be offered to association members is free mailing of tournament flyers. All you have to do is mail a copy of the flyer to Jim Manders, P.O. Box 2192, Sequim, WA 98382, and it will be sent to everyone on our mailing list. Flyers should be received by the 20th of each month and you should probably mail about two months ahead of your tournament.

One question: We have a lot of travelling shufflers; if someone beyond the borders of Washington, Oregon and British Columbia participate in a sanctioned tournament, can they qualify for ESA points if they pay the \$15 dues? Or is membership restricted to shufflers and sponsors in those areas? Keep us posted on your progress.



I received my "February" issue of *The Board Talk* today. I understand now why Blinky's may have had a lousy turnout this year for their Presidents' Day Tournament, if everyone else also received their February issue the day AFTER the tournament ended. Maybe you should have just called it the March issue and published an announcement that February was cancelled.

There isn't anything that makes us feel worse than to hear the news that an issue that includes a tournament flyer arrives too late! That's why, time after time, we encourage tournament sponsors to advertise early. With our bulk rate permit, it can take from one to three weeks for the Post Office to deliver, depending on location, volume of mail, etc. We are currently taking feedback from subscribers to determine whether they are willing to pay a premium for first-class mailing.

When we went to the PCSA's Extravaganza in Las Vegas on Jan. 31, we took 100 copies of all the flyers in the February issue along for distribution to that important audience, so they were aware of Blinky's event three weeks in advance. Also included were flyers for Wetlands (March 17-19) in Michigan, Jimmy L's (March 17-19) in Oklahoma, Huddles (March 24-26) in Florida, and Shotze's (June 17-18) in Washington, all of whom recognize the benefits of advertising early.

In defense of Blinky's, their Presidents' Day Tournament has been on the Calendar of Events since November 1994. This calendar is published each month at our own expense and we hope that investment pays off in dividends of reader participation.

Advertising revenue is crucial to us and we appreciate the support of Blinky's and all others who support this publication with their advertising dollars. Without that support, we could not remain a communications vehicle for the sport of shuffleboard. However, because of your feedback, David, we will be even more aggressive in the future in refusing advertising of tournaments that are "borderline" in terms of arriving at subscribers' mailboxes before an event occurs.

A good rule of thumb, as we've encouraged many times before, is to plan ahead and advertise your events well in advance. Follow the lead of those who advertise early and succeed...... (1) place your event on the calendar just as soon as your dates are firm -- a year in advance is not too early! (2) order your flyer at least two to three months in advance (the PCSA, Shuffleboard Federation, and Board Talk events, which solicit advance registrations, advertise up to six months in advance).

The advantage of investing (we prefer to call it an investment rather than an expense) in a flyer is that it not only reaches our subscribers, but they are encouraged to post it in their favorite shuffleboard establishment, which multiplies the message many, many times. Also, even though you purchase a flyer in May for an event in September, your message doesn't end there. Each month thereafter, your event is promoted in subsequent issues through the calendar and other columns in *The Board Talk* at absolutely no cost to you.

Our apologies to you, David, and to Blinky's. The February issue was mailed on Jan. 27, so delivery on Feb. 21 certainly is not acceptable. (Why the 27th when closing was the 15th? Good question! The 15th fell on a Sunday; Martin Luther King Jr. Day was on the 16th, with no mail delivery. It took 10 days to set last minute reports, get it printed, stuffed, stapled, and prepared for delivery to the Post Office.)

It wouldn't be a bad idea to let your mail carrier or local Post Office know that you are concerned about the late arrival of your Board Talk! We all receive a bundle of "junk mail." Maybe they need to know that The Board Talk doesn't fit in that category.

Because of your letter, when we received a call to insert a flyer regarding the 3rd Annual A-B-C Draw Tournament at CC's Sports Bar in Anaheim, California, on April 7-9, we reluctantly offered to withdraw that opportunity because we could not guarantee delivery before the event. They opted to take that chance just to let The World of Shuffleboard know that they are an active and viable location for shuffleboard action and hope that shufflers will support their next event in the fall. We salute them for that aggressive attitude and hope that shufflers across the U.S.A. and Canada will show their appreciation, not only for supporting us with advertising revenue for this one event that may arrive too late to participate, but for year-around support through the Shuffleboard Directory.

Bless them; they keep us optimistic about the future of shuffleboard and *The Board Talk!*

Many of you tell us you read each month's issue from cover to cover and that's always good to hear. We hope you mean that and don't take the last page for granted because it contains the names of those who keep this publication going and they deserve recognition: first, our advertisers, and second, our subscribers.

If it were not for our advertisers, there would be no way we could bring you news and views from The World of Shuffleboard, so we encourage you to patronize those businesses and take time to say "thanks" to them for supporting your communications vehicle.

On the other hand, if it weren't for our subscribers, they wouldn't advertise! So, take a bow yourselves........... While there are no changes in the standings of our top six shuffleboard subscriber states, there are some noteworthy statistics that don't appear in those standings. First, those six states account for over 60% of our subscribers, which speaks well for the commitment of shufflers in those states to the sport of shuffleboard and to *The Board Talk*. Second, while the standings remain the same, there have been some significant shifts: California this month surged well beyond second-place Michigan, mainly because of their retention record. Number four Washington, because of new subscribers and retention, is nipping on the heels of number three Texas. And number five Indiana holds only a one-subscriber edge over number six Oklahoma.

Our second "layer" of states, which account for 20% of our mailing list (Florida, Maryland, New York, Nebraska, Oregon and Pennsylvania -- in that order), are a ways from breaking into that top six standings, but with a little effort on the part of current subscribers, they could make it happen.

Darlene's Place -- new name, old place that has really been dramatically changed. Remember Ours and Your Place in Sudlersville, Maryland, operated so long by Joann and Art Ware who really established shuffleboard tournaments on the eastern shore of Maryland? 




